- No monthly volume commitment required.



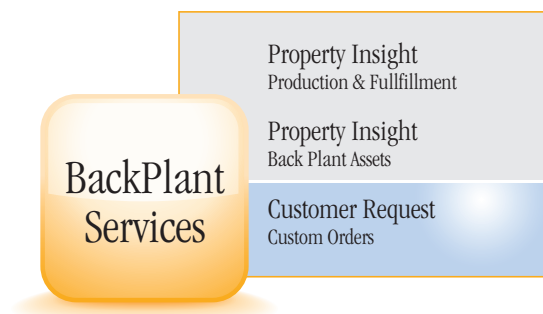

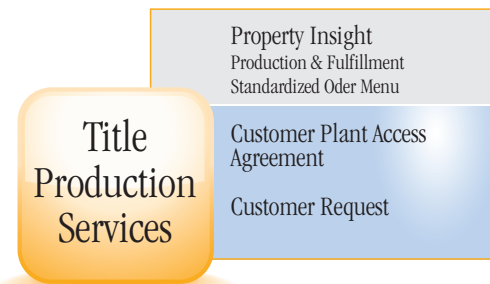
## Title Production Services
